

HOUSE LEGISLATIVE INITIATIVE 18-12 (English)

This initiative proposes a constitutional amendment to the level of funding mandated for the Public School System (PSS). The only change is from a guaranteed annual budget of 15% to a guaranteed annual budget of 25% of the general revenues of the Commonwealth. This budgetary appropriation is not available for re-programming.

The purpose of the proposed initiative is to provide greater financial support to PSS and to bring CNMI education funding to the same funding level as found in other state jurisdictions of the US.

PROS

This amendment will guarantee that a future Legislature cannot decrease PSS funding below 25% of general revenues. Without a constitutional amendment, the Legislature is free to restrict spending to PSS to the minimum guaranteed 15%. The pressures of other obligations during budget time makes the budget process political and education needs may suffer in that process without this proposed change.

On average, 25% of state revenues are spent on K-12 education in the 50 states and the District of Columbia. The proposed change would guarantee a higher level of funding to the CNMI PSS than currently exists. This increase would make the CNMI's education funding match that spent in the US.

The CNMI Constitution guarantees free public education. It is useful to have an educated population for participation in civic affairs and for the general benefit of the community. A mandate for 25% funded education system may help meet the constitutional promise and provide greater educational opportunities and better quality education.

CONS

The amendment restricts Legislative flexibility to address problems with budget appropriations. The Legislature would have less money available to it for appropriations for other government functions. Right now, the Legislature may direct 85% of general revenues, subject to other constraints. This gives the Legislature the flexibility to spend general revenues on matters it deems pressing or important. With the change from the proposed amendment, the Legislature would have only 75% of general revenues to direct towards other government functions.

Some other government departments or funded activities will get a smaller percentage than they receive now. Increasing PSS funding may hurt some other important and

necessary governmentally-funded work. If PSS must get 25% of the general revenues, the Legislature would need to raise taxes or find other ways to increase the government revenues to maintain current levels of spending in other areas.

The Legislature is presently permitted to fund PSS at 25% or more if it decides that is what to do with the limited resources of the CNMI. A constitutional amendment isn't necessary to allow this to happen if the Legislature wants to direct that much of the budget to PSS. It may not go below 15%.

CONCLUSION

The proposed amendment is consistent with and would achieve its intended purpose to increase PSS support and bring CNMI's contribution to K-12 education in line with spending in the 50 states of the USA. However, increasing PSS's budget means that some other government-funded activity or function will receive less; the government will have to raise more revenues to maintain its current spending level for those other activities and functions.

HOUSE LEGISLATIVE INITIATIVE 18-12 (Chamorro)

Esti na apropositun budgetary ti gumuaha para i re-programming.

I hinangai maproponi na initiative para u na'guaha ladangkulu na suppotasion fainansiåt para i PSS yan para u na'hålum fondun idukasion CNMI gi parehu na funding level kumu masodda' gi halum ottru state jurisdiction giya US.

Esti na amendasion para u garentia i mamamaila' na Leyislatura ni ti u na'menus i fondun PSS gi papa' bentisingku (25%) put sientu gi general revenues. Sin i constitutional amendment, i Leyislatura u free gi prinibin ginasta para i PSS guatu gi minimum guaranteed gi kinsi (15%)put sientu. I pressures gi ottru opbligasion siha gi duråntin oran

budget ha fa'tinas budget process political yan education needs anai siña ha na'famadesi ni atyu i process sin esti i maproponi na tinilaika.

Gi average, i bentisingku (25%) put sientu gi state revenues manmagåsta gi K-12 na idukasion gi halum singkuenta(50) states yan i District of Columbia. I maproponi na tinilaika para u garentia i higher level na finondu para i CNMI PSS ki prisenti ni gaigi. Esti na inåomenta para u na'guaha i CNMI's education funding match ni magåsta gi halum US.

I Konstitusion CNMI ha garentia i free public education. Gef båli para u guaha educated population para pattisipasion gi halum civic affairs yan i benifisiun heneråt gi kumunidå. I ma'otdin na para bentisingku (25%) put sientu ni mafondu i sisteman idukation siña inayuda umafakcha' i constitutional promise yan ha prometi ladangkulu na opottunidåt idukasion siha yan mås måolik na kualidåt idukasion.

På'gu na ora, i Leyislatura siña ha direct i otchentaisingku (85%) put sientu gi general revenues, masuhetu para ottru na constraints. Esti ha nå'i i Leyislatura ni flexibility ni para u gåsta i general revenues gi manera siha ni ha kunsidera humonñu' pat impottånti. Ya i tinilaika ginin i maproponi na amendasion, i Leyislatura siña gumuaha ha' sitientaisingku (75%)put sientu gi general revenues ni para u na direct guatu gi ottru na fungksion gubietnamentu siha.

Guaha ottru dipattamentun gubietnamentu siha pat aktibidåt siha ni manmafondu para u fanmanå'i ladididi' na percentage ki håfa marisisibi på'gu. An mahåtsan i PSS funding siña chini'ut palu ottru ni manimpottånti yan nisisåriu na governmentally-funded na cho'chu'.
