 for good cause, the Commission may extend the deadline imposed on Section 6424 by not more than fifteen (15) days, upon written request by a candidate. A candidate shall be fined a nonwaivable One Hundred dollars (\$100.00) penalty for each day the financial report is late without a Commission approved extension period.
