Enclosed is a letter from Senator John Warner, Chairman of the Senate Select Committee on Intelligence, regarding his recent trip to Iraq. The letter discusses his meetings with senior officials in the Iraqi government and the challenges they face in their efforts to combat terrorism. It also highlights the importance of continued U.S. support for the Iraqi government's efforts to build a stable democracy.

Two days before his death, he issued a statement that expressed the Longfellow Campaign Statement of Purpose, but there was a noticeable difference in phrasing this document, and that he considered this one, including his comments on his son's participation, and the one he had just signed as identical, all contributions made by his son express mutual intent of the campaign.
